AccuRead

Components:

- ABS Plastic Body
- Battery Compartment
- Large LCD Screen
- Celsius/Fahrenheit Button
- Stainless Steel Probe
- Battery Door

Functions:

- Large LCD screen with back light
- Temperature range: -58°F to 572°F
- Temperature accuracy: 32°F to 212°F +/- 0.5°F
- Readings in 1 seconds
- Display rotates 180 degrees
- CR2032 battery included
- IP67 waterproof

Power:

Open the probe to the extended position and the LCD will illuminate.

Shut Off:

Put the probe in the closed position to turn off.

Intelligent Backlight:

When the instrument is turned on, a light sensor continuously monitors ambient light levels. As it gets darker, the intelligent backlight comes on automatically to read the digits in any light condition. Covering the light sensor will also turn on the backlight except in well-lit areas. The backlight will remain on for about 10 seconds.



Auto-Off:

The instrument will automatically turn off if it is not used for about 3 minutes.

Fahrenheit & Celsius:

Set to Fahrenheit as a default. To switch from Fahrenheit to Celsius, open the probe to turn it open and press the °C/°F button on the back of the thermometer to switch between scales.

Temperature Reference:

Poultry 165°F
Beef—Well: 160°F
Beef—Medium: 140°F
Beef—Medium Rare: 130°F
Lamb—Well: 160°F
Lamb—Medium: 140°F
Lamb—Medium Rare: 130°F
Pork—Well: 160°F
Pork—Medium Rare: 145°F

Cleaning:

Wipe clean with a damp sponge or cloth. Do not use solvent-based cleaners or methylated spirits. Thoroughly clean the thermometer after each use to avoid cross contamination.

Storage:

Store closed. Avoid crowded drawers where the probe can catch on utensils or kitchen tools to prevent damage.

Changing the Battery:

Unscrew the battery door. Tap the door off into your hand if its stuck after unscrewing. Replace with a new CR2032 battery with the + side up. Replace the battery door and screw back in.

Warranty:

Limited Warranty GreenPan AccuRead Digital Thermometer is covered by a limited warranty against defects in materials and workmanship beginning on the date of purchase and lasting for five (5) years.
